International Ethics Olympiad | July, 2025

- The Neerja Modi School was the one of three institutions from India to participate, competing on cases from robot love and assisted dying to copyright, data, and prenatal scanning. Out of 150+ teams worldwide, we placed 7th internationally, ranking in the top 5%.
- Currently training the next cohort of senior students, who have qualified for the national selection round, as well as 5 middle school teams that placed 1st and 2nd at the regionals and advanced to the national round in January 2026.

Philosophize Direct

- Student-led, peer-reviewed journal that advances philosophical literacy and public reasoning among high school and undergraduate students.
- Each submission undergoes a rigorous double-review process, including peer feedback and formal review by two university-affiliated professors, ensuring both academic integrity and accessibility for young thinkers.
- 3 issues published including argumentative essays, conceptual reflections, and cross-disciplinary analyses.
- Organised workshops, book discussions, interactive lectures, and video explainers on core philosophical problems and their intersections with fields such as political science, literature, and the sciences.
- Established Philosophize Canvas aimed at introducing high-school students (800 in 8 schools) to short, engaging lessons in aesthetic philosophy and phenomenology to morality, and then guided them in translating these ideas into tangible works of art (1,500 produced).

Baltic Sea Philosophy Essay Event, 2024 (Honorary Mention)

• In this essay, I argued that genuine freedom is ontologically incompatible with societal conformity; drawing on Marcuse's *repressive tolerance* and Sartre's *bad faith*, I contended that true autonomy emerges only through resisting the normative structures that create the illusion of choice.

John Locke Essay Competition, 2024

• <u>Theology (High Commendation):</u> In this essay, I argued that the 'spiritual but not religious' worldview is philosophically untenable, demonstrating through a constructivist framework, drawing on William James, Charles Taylor, and Adam Tyson, that spirituality and religion are epistemologically and culturally co-constituted rather than isolable frameworks.

- <u>Philosophy (Commendation)</u>: In this essay, I argued that moral responsibility presupposes conscious awareness, contending, drawing on Descartes, Fodor, and Freud, that only conscious belief-states, not subconscious or unconscious ones, constitute genuine agency.
